Reading Council's consultation on Rights of Way:

Runs until 19th February – we can consider a group response at January and February meetings but please also make individual responses.

They ask for suggestions:

- Identifying new paths including creating new paths as part of new developments;
- Reviewing suggestions for historic routes and exploring options with the aim to claim or reinstate them;
- Focussing on removing barriers for cyclists such as gates and narrow paths, and on paths for those with restricted mobility and visually impaired such as gates, surface, gradient, and width;
- Long-term addition of street-lights on existing dark paths.

Caversham Golf Course

Having got planning permission for 223 new homes with Air Source Heat Pumps the Golf Club have sold to housebuilders Vistry Thames Valley who now say they want to switch most of the homes to gas boilers because the local electricity supplier says it cannot supply enough electricity to the site.

The electricity suppliers should be told to get with the decarbonisation programme – although a switch to ground source heat (as our objection recommended Reading Friends of the Earth (readingfoe.org.uk)) should reduce peak demand and overall electricity use and costs to consumers.

CPRE on housing numbers:

CPRE 2022 state of brownfield report shows that the availability of previously developed land continues to grow across England. In summary, it has found that over 1.2 million homes could be built on 23,000 sites covering more than 27,000 hectares of brownfield. Government proposing changes to National Planning Policy Framework:

Consultation – released on 22nd December - runs until March. Should give local authorities some more control over local development.

Government says it aims to deliver its commitments to building enough of the right homes in the right places with the right infrastructure, ensuring the environment is protected and giving local people a greater say on where and where not to place new, beautiful development. It will also deliver cheaper, cleaner, more secure power in the places that communities want to see onshore wind. A quick look suggests it may do little new on housing numbers and on energy efficiency but Wokingham Councillors have expressed optimism that it may help to reduce pressure for greenfield housing in Wokingham Borough.

Met Office Report on UK's Hottest Year on Record:

Study shows human induced climate change made the UK's record-breaking annual temperature around 160 times more likely. Useful (worrying) graphs comparing 2022 with average 1991 to 2020. Climate change drives UK's first year over 10°C - Met Office

Windfall tax on renewables:

In response to the Chancellor's autumn statement in which he said the government would add a 45% tax on revenue to UK renewable energy generators Thrive Renewables issued a critical comment arguing that the government's approach will incentivise investment in fossil fuels. John Booth tries to remember the 1970s

People and governments can only take decisions on proposed actions based on the available information at the time. Sometimes the right decision is not to say 'yes' or 'no' to a major project or new strategy but to defer commitment – perhaps while calling for more research or investigation.

FoE as an environmental campaigning organisation aimed – among other things - to ensure that when people and governments take decisions environmental issues are given appropriate weight compared to economic, political and social arguments. Often it is an argument: long-term risk and uncertainty against short-term gain. I see us as operating on the interface between science and politics.

Back in 1975/76 I first became involved in nuclear and energy issues with Portsmouth FoE. As I recall the state-owned Central Electricity Generating Board and British Nuclear Fuels were planning 11 new nuclear power stations around the country and a Thermal Oxide Reprocessing Plant (THORP) at Windscale/Sellafield.

- Britain was an island made of coal and surrounded by fish.
- North Sea Gas was in use and Oil was coming.
- Arrhenius in 1896 had identified that CO2 from use of fossil fuels could eventually result in global warming but had predicted it would not be serious for 3,000 years.

In 1975 'Fuel's Paradise' was published – an Open University set book on Energy Options for Britain. The author discussed climate risks from a 'greenhouse effect' and from other consequences of ever-growing energy consumption and concluded that more research was needed on how the global climate works. He also criticised the "polarity between the 'hard-line fixers' of the CEGB and the 'eco-nuts' of Friends of the Earth".

In 1976 the Royal Commission on Environmental Pollution report on Nuclear Power and the Environment was released. Chapter XI is a 'Summary of principal conclusions and recommendations'. The last recommendations – numbers 42 to 50 (Chapter XI – page 204 in the book, page 215 in on-line page numbering (link below)) make it very clear that as recommendation 45 put it "a major commitment to fission power and a plutonium economy should be postponed as long as possible."

So nuclear had a case to answer. I think it was entirely reasonable in 1975 to 1980 to campaign for use of fossil fuels and energy conservation, and for development of renewables, instead of massive rapid expansion of nuclear facilities.

THORP went ahead after the Windscale Inquiry. Despite on-site protests construction of Torness and Heysham 2 power stations started around 1980 and Sizewell B came later. FoE and others did not stop nuclear power but probably helped to slow its implementation and make it safer in operation.
