**River Action - presentation by Chloe Peck** (communities coordinator for the charity River Action) at 8:00 pm by zoom – to share their plans for the next year and give guidance as to how to take action to save our local waterways. <u>https://riveractionuk.com/</u>

- River Action is a small charity with a mission to rescue Britain's rivers. Last summer, River Action worked alongside community groups in Henley on Thames to test the Thames for phosphate, nitrate and harmful pathogens, all indicators of sewage run off.
- In 2024 they plan to partner with British Rowing to test the water quality of the Caversham training grounds, as well as different sites along the Thames.

# **Recent Activities**

- Clean Air and Safer Transport Forum: Chris and John attended RBC's CAST Forum on 30<sup>th</sup> November. Highlights:
  Air Quality Update
  - Smoke Control Area to be increased from 62% to 100% of Borough in 2024 but compliance and effectiveness seem to be variable. <u>https://www.reading.gov.uk/climate-and-pollution/smoke-controlareas-smoke-control-areas/</u>
  - Schools Air Quality Awareness Programme to cost £327k need schools to sign up to be involved. <u>https://www.reading.gov.uk/climate-and-pollution/clean-air-living-matters-exploring-reading-with-</u> schools/
  - Air Quality Action Plan AQ has improved but still a few non-compliant hotspots (IDR, Friar Street, Cemetery Junction) against current legal limits. Consultation to run from December.
  - Strategic Transport Update
    - Reading Transport Strategy 2040 consultation in progress. Councillor Ennis still keen to reduce through traffic.
    - Bus Service Improvement Plan £26 million spending in progress.
    - Active Travel Schemes discussion of improvements.

**Reading Minster Display:** Tricia Marcouse arranged with Reverend Sonya Wratten for our 'Warm Homes' display to be on show with material from Econet and Draught Busters in the weeks leading up to Christmas.

# "Reading for Warm Homes" - petition to Reading MPs – sign now!

Including 'on-paper' signatures we now have about 150. National target date for presentation to MPs was 18<sup>th</sup> November but we can continue for the moment. We need to decide when to arrange to present it to MPs and when to stop collecting signatures. There may be an opportunity to re-use the petition signatures in the run-up to the expected election in the new constituencies.

Petition calls for:

Urgent support for people dealing with sky-high energy bills. A new emergency programme to insulate our heat-leaking homes An energy system powered by cheap, green renewables.

# **Reading Air Quality Plan Consultation:**

Please respond to <u>https://consult.reading.gov.uk/dens/air-quality-action-plan-2024-2029-consultation/</u> and help to create a group response. Closes 17<sup>th</sup> January 2024.

Councillor Ennis' introduction admits that "we still have some locations in the Borough which are above the UK and World Health Organization (WHO) air quality limits."

The plan has been developed in recognition of the legal requirement on the local authority to work towards Air Quality Strategy (AQS) objectives. It includes a great deal of interesting data and analysis.

On an initial 'skim' reading the following points seem relevant:

- Acknowledges importance of PM2.5. But this is only measured at the 'Urban Background' site in the cemetery which is probably not representative of levels inhaled by people in worst-case locations. Does not seem to explain how and where PM2.5 concentrations are going to be measured.
- In discussing long-term and short-term effects does not seem to differentiate between effects of NO2 and PM2.5. Does not discuss potential impact of short-term periods of relatively high pollution caused by temperature inversion. Does not give meaningful/comprehensible estimates of likely effects on people in Reading of each pollutant, so does not suggest how health will improve as air quality is improved.
- Does not explain difference between UK objectives and (much tighter) WHO objectives.
- Does not explain how much of PM2.5 inhaled by people is regional background requiring change elsewhere
   and how much is due to local emissions in Reading.

National FoE analysis was covered in Reading Chronicle in October finding 95 neighbourhoods in Reading were exposed to air pollution exceeding the World Health Organisation recommended safety limit. This meant approximately 157,000 people were breathing polluted air in the area in 2022. https://www.readingchronicle.co.uk/news/23849154.dangerously-high-air-pollution-nearly-reading-neighbourhoods/

# Reading Plan 'Partial Update' Consultation:

Please respond to <u>https://www.reading.gov.uk/planning-and-building-control/planning-policy/new-local-plan/local-plan-partial-update/</u> and help to create a group response. Closes 31<sup>st</sup> January 2024. It is a large and complex document so need to pick key areas on which to comment.

The Local Plan sets out the strategy for how new development takes place in Reading. This consultation is on Scope and Content and does not yet include draft updated wording, but instead it generally describes how the Council expect to change certain policies. It suggests that government estimates of need to increase housing may be excessive.

Among other areas it looks to strengthen the policies that deal with climate change and environmental impacts, now including 'embodied carbon'. We should find out how it integrates with the Berkshire Local Nature Recovery Strategy <u>https://rbwmtogether.rbwm.gov.uk/berkshire-local-nature-recovery-strategy</u> (that is under development) to deliver 'Biodiversity Net Gain'.

The 'Sustainability Appraisal' considers each option for a policy or site, in turn, and examines it against a range of environmental, social and economic objectives. Instead of 'limiting the impact of climate change' it now seeks to 'address the climate emergency'.
