# Waterfest - Wrong Sort of Rain.

This year on 16<sup>th</sup> June the Waterfest reverted to the Forbury location because excess rain and waterflow had prevented many canal boats from assembling. Despite some strong winds and ocasional showers we had a reasonable number of visitors to our stall.

Fifty-five people signed our postcards to MPs – calling for a 'Clean British Energy' revolution - and were awarded 'CBE' badges or stickers. Some were happy to be photographed in our athletics-themed 'Brighton Board'.

The messages to MPs are that:

- Parliament is debating Electricity Market Reform this year, but Government plans look set to continue with expensive imported gas; risky nuclear power; and domination by just six companies who make huge profits while thousands live in dangerously cold homes.
- It's time to open up the electricity market to allow smaller companies to compete, and businesses, councils community groups and individuals to generate their own electricity.
- Cutting energy waste and switching to Clean British Energy is our best hope for affordable fuel bills in future.

We also gave out information on two small, 'green' electricity suppliers - Ecotricity and Good Energy.

The stall next to ours was run by Transition Town Reading who are proposing to run events based on the national FoE "Bee Cause" campaign.



#### Reading Climate Change Strategy Revision.

In January 2012 the Reading Climate Change Partnership (RCCP) began the process of developing a new Reading Climate Change Strategy to run from 2013 to 2020.

After the 'Reading Means Business on Climate Change' meeting in January and the launch of the consultation process GREN held a meeting on Saturday June 9<sup>th</sup> for members of environmental groups to get to grips with the process. Drafts of strategy chapters were reviewed at a meeting of the Green City Forum, attended by around 70 people, in the Civic Offices on June 27th.

The intention is for the eight "Theme Leads" to have draft action plans available for review by the end of July 2012. Since the GREN and Green City Forum meetings this on-line forum has become much more active with many interesting points being made – some of which probably need to be questioned or strengthened ....

The RCCP is a sub group of the <u>Reading Local Strategic Partnership</u> which will help to develop and deliver the Sustainable Community Strategy and the Reading Climate Change Strategy. Reading Borough Council has a <u>Climate Change Strategy</u> for the period 2008-2013.

### Less and More Support for Renewables....

The Feed-in Tariff for Solar PV will drop again on 1<sup>st</sup> August to 16p per kWh for an individual household installation rated at less than 4 kW, which the government estimates gives a return of 6% per annum. Further cuts of 3.5% every three months are anticipated if installations are at sufficiently high levels. The FiT will now last for only 20 years - formerly 25 years, but the 'export tariff' will rise from 3.5p to 4.5p.

The Renewable Heat Incentive – to make payments for renewable heat used - is now in place for non-domestic installations of ground- and water-sourced heat pumps, small biogas, solid biomass, solar thermal, and geothermal. In practice it is applicable to domestic installations shared by more than one property. Government has adopted a mechanism to limit cost to £70m this year – it expects expenditure will be £42m. Again payments will last for 20 years and be linked to the RPI – return estimated to yield 12.5% initially for the median participant. Government will be running two further consultations over changes to the scheme including tariff for single domestic installations.

The Environmental Audit Committee's inquiry into Sustainable Food said there "should also be provisions in Local Plans to ensure that communities are provided with open spaces to grow their own produce, including for example options for communities or co-operatives to buy land for these purposes". It welcomed support for food waste collections and said that while the overarching aim behind the Government's work in improving the UK's food system is 'sustainable intensification' the emphasise should be on 'sustainable'. Policy must take account of social and environmental impacts of the food system, including retaining space for small scale production practices and local food networks. http://www.publications.parliament.uk/pa/cm201012/cmselect/cmenyaud/879/87909.htm

#### **Peak Oil**

Slides from Dr. Roger Bentley's talk to the Earley Environmental Group on 25<sup>th</sup> April are available from <a href="http://www.earleyenvironmentalgroup.co.uk/Environment/PeakOilTalk.asp">http://www.earleyenvironmentalgroup.co.uk/Environment/PeakOilTalk.asp</a> Dr. Bentley's analysis was in terms of conventional oil supplies, and he concluded that 'unconventional' supplies would be available at higher prices.

Interestingly George Monbiot has recently taken a different view – suggesting that 'Peak Oil' may be some way off because of 'unconventional' supplies http://www.guardian.co.uk/commentisfree/2012/jul/02/peak-oil-we-we-wrong.

One of the comments on Monbiot's article recommends this article in the 'Energy Bulletin' <a href="http://www.energybulletin.net/stories/2012-07-02/peak-denial">http://www.energybulletin.net/stories/2012-07-02/peak-denial</a> which reckons \$100 dollars a barrel is needed to justify new projects and continues "However the main thing to take from this is that conventional oil did probably peak several years ago." Unconventional sources also give a lower energy return on the energy invested in them."
