Other groups there included Reading Hydro, Reading Community Energy, Econet, and Global Justice Now.

One end of the marquee was a presentation space with projector and PA and seating.

John twice gave a short presentation about 'Reading for Warm Homes'. Audience numbers were small but there were helpful comments about fuel poverty in Reading.

"Reading for Warm Homes" - petition to Reading MPs - sign now!

Including 'on-paper' signatures we now have 55 so need many more over the coming months! National FoE say they will send to their list of local supporters – which should be helpful - but they can't do it for a while.

Our petition is live on the 'Action Network' so now we need more signatures to present to the MPs (with wider publicity!) in the autumn – national target date is 18th November. Please help us publicise this initiative to other local people and concerned groups. We will be happy to supply leaflets, petition forms, draft articles for newsletters ...

Petition calls for:

- Urgent support for people dealing with sky-high energy bills.
- A new emergency programme to insulate our heat-leaking homes
- An energy system powered by cheap, green renewables.

Reading Borough Council - Strategic Environment Planning and Transport Committee - June 29th:

Councillor Page has become Mayor so key Councillors for environmental issues now are:

- John Ennis Lead Councillor for Climate Strategy and Transport
- Mickey Leng Lead Councillor for Planning and Assets
- Karen Rowland Lead Councillor for Environmental Services and Community Safety
- Will Cross Chair Cleaner Air & Safer Transport Forum Chair Strategic Environment, Planning and Transport

Reading Transport Strategy 2040. Lead Councillor John Ennis confirmed Labour's support for a new Thames road bridge and opposition to 'congestion charging' for Reading residents. Cllr. Brock had previously written "there is no proposal to charge Reading residents or Reading businesses for entering a cordon" while not ruling out other forms of 'demand management' https://www.readingchronicle.co.uk/news/around/23587254.prospect-congestion-charge-reading-shut/

Green Cllr. McElroy was very critical of the strategy and said its ambitions were too cautious. Reading FoE should consider it in detail and respond to the consultation when it opens. https://democracy.reading.gov.uk/documents/s27712/Appendix%20A%20-%20Draft%20For%20Consultation.pdf

Other topics addressed at SEPT included:

- a draft Electric Vehicle Charging Infrastructure Strategy for Reading,
- an update on the progress made towards the delivery of the current programme of strategic transport schemes in Reading,
- declaring the whole of the Borough a smoke control area to address air quality impacts
- progress with implementation of the Council's Low Carbon Energy Capital Investment Programme.

Reading Borough Council - Clean Air and Safer Transport Forum - July 4th

This meeting was attended by four Reading Councillors and five members of the public including Graham and John. We heard from specialist council staff on Air Quality and the emerging Transport Strategy. The anticipated presentation on Network Management was not given because the relevant staff member was not available.

Air Quality -

Diffusion tube measurements of NO2 in key locations still around national target of 40 ug/m³ which is way above WHO figure of 10 ug/m³. Council turning attention to PM2.5 but can only measure it at one location in the East Reading Cemetery. Did not seem to know where funding for more monitoring was going to come from.

John said that it would be good to have estimates of health implications of current levels of pollution – to understand how concerned to be.

Graham asked if impact of proposed incinerator at Burghfield would make much difference to air quality and if there was progress on planning conditions proposed to be applied to it – we did not receive a clear answer.

Air Quality Action Plan is to be updated – with new UK targets (which still fall short of WHO) - will go to SEPT in November.

£327k grant is to be spent commissioning a programme of education to raise awareness of Air Quality in local schools. Perhaps in hope that children will encourage parents to change behaviour.

Smoke Control Areas are to be enlarged to encompass the whole Borough. People could be fined up to £300 if found to be burning un-approved fuels.

Strategic Transport Update

John said that while strategy was to run to 2040 it was important to have shorter-term targets.

Reading Climate Festival:

This Climate Festival event was set up by Reading Borough Council staff and featured a number of contributors from other organisations. It included a presentation on a plan to extract heat from the Thames and create a heat network with an Energy Centre between the Thames and the railway to power expected redevelopment using heat pumps. https://www.youtube.com/watch?v=LZY1tnXUZKw

National Climate Policies:

- "The Authority recognises that a comprehensive suite of policies including funding, regulation and carbon pricing is needed to deliver the decarbonisation we need this decade and beyond." It's good to see acknowledgement of urgency to achieve change 'this decade' rather than the 'Net Zero by 2050' mantra ...
- It's also good that "domestic maritime transport, waste incineration and energy from waste sector will be added to the scheme." ... but with what allowances?
- But optimism is sapped by the statement "To ease this transition, the cap will be set at the highest level of the range consulted on, in line with net zero allowing maximum flexibility for industries. Extra allowances will also be made available to the market between 2024 and 2027... "

Five Missions: Last week the **Labour Party** announced that, if elected, it would deliver a national warm homes plan, giving local authorities and devolved governments the power and resources to upgrade 19 million homes with energy-efficiency measures, via a street-by-street insulation programme. https://labour.org.uk/wp-content/uploads/2023/06/Mission-Climate.pdf
