Recent Activities with Reading FoE:

Air Quality: On 8th May our monthly meeting at RISC and on Zoom was attended by Olivia Bailey - Labour candidate for Reading West and Mid Berkshire - and by invited guest speaker Ross Jarvis – Reading Borough Council's Principal Air Quality Project Officer.

Ross spoke about the **Clean Air Living Matters** project. This aims at engaging children in schools about Air Quality issues. It is funded by £327k from DEFRA and was designed and is being delivered by local company Design Nature with involvement of Reading University, Stantec, and RBC. It runs to March 2025.

To involve children it has 10 static and 20 mobile air quality sensors, measuring various pollutants including PM10 and PM 2.5, with which they can create an air quality map of their area. Also measured are CO2 and Volatile Organic compounds.

Children learn to **Reduce** sources of air pollution or **Move** away to less polluted spaces. Primary school children get a document to take home to involve parents.

CALM hopes to reach 9 secondary schools and 24 primary schools – delivering assemblies, talks and activities – including for geography or science lessons. So far involving 2 secondary and 6 primary schools. They are keen to contact more schools to engage with and Ross asked us for any help we can give.

Warmer homes and heat pumps: Stalls at **Waterfest** (8th June) and **East Reading Festival** (23rd June) saw us talking to members of the public and a number of Councillors, and two candidates for Parliament, about climate change, heat pumps, and other topics.

At Waterfest Dr. Rayner Mayer of 'Sciotech Projects, Yateley', former Chair of the European Heat Pump Association, gave a presentation on the Forbury bandstand on warmer homes, insulation, and heat pumps. Unfortunately it was not well publicised but the few people who attended found it very interesting.

Thanks to Rayner Mayer for presentation and to Chris, Vicky, Mark, Tricia, Anne and John for help with stalls.

Reading Climate Festival: On 11th June we took part in a Reading Climate Festival webinar "Campaigns to Change Systems" with Global Justice Reading, Berkshire Greenpeace and XR Reading. Each group outlined key recent campaigns. Event was recorded but is not yet on-line.

Reading Climate Action Network - help develop new strategy:

RCAN is a partnership working to help Reading become a net-zero, climate-resilient town – with support from the Council and business and voluntary organisations. https://readingcan.org.uk/about-us/

They have designated 2024 as 'Reading's Year of Climate Engagement'. They want people and groups to get involved to help shape Reading's Climate Emergency Strategy 2025 – 2030. This will be the fourth Climate Strategy – and will set targets for the Council and others. https://readingcan.org.uk/priorities/.

After this there are two more periods of involvement as the strategy is developed.

"Reading for Warm Homes" - our petition to Reading MPs

In view of the imminent election we closed this petition in early June, and – as by then we suddenly had no MPs – e-mailed all the candidates (for whom we had addresses) in our three constituencies. Total unique signatures: 198

- In Reading Central: 106
- In Earley and Woodley: 45
- In Reading West and Mid Berkshire: 22

One Green Party candidate responded to support our request for support.

We also put out a Press Release which we're not aware was taken up by any media.

Clean Air and Safer Transport Forum:

On 2nd July John Sharpe and John Booth attended this RBC 'group representatives by invitation-only' event to hear RBC officers Ross Jarvis (Principal Air Quality Project Officer) and James Turner (Transport Planner). The meeting was well-attended by RBC Labour Councillors including John Ennis (Lead Councillor for Climate Strategy and Transport), several representatives of cycling action groups and CADRA, and Cllr. James Moore (leader of the Liberal Democrats).

Ross Jarvis presented 2023 data for **air quality**. NO2 average of of 56 sites was 33 ug/m^3, one site exceeded legal limit of 40 ug/m^3 but would have been legal at nearest residential receptor. PM2.5 legal at the only measurement location (urban background) but a new Defra site had been commissioned on Rose Kiln Lane and RBC expected Ministry of Public Health to commission more near schools. He agreed that while electric vehicles would solve tailpipe emissions particulates from tyres might well increase for heavier vehicles and the effects of different particulates on health were uncertain.

Two new school streets to open before summer holidays. Council struggling to get 'before' Air Quality data for Civtas site. Still want more schools to join CALM programme.

Reading's **Electric Vehicle Strategy** was discussed. Funding of £866k had been agreed from the LEVI fund https://energysavingtrust.org.uk/grants-and-loans/local-electric-vehicle-infrastructure-scheme/. Aim is to install 2,700 on-street chargers and 120 fast chargers in car parks. Approval of Action Plan awaited. Will put out to private enterprise suppliers – hope to agree 15 year contracts by end March 2025. Hope to agree some limitations on pricing. John Sharpe suggests agreeing a % above domestic tariff rates and that shorter supply contracts should be sought.

Some existing charge pointes were well-used, some not so well. Major concerns over electricity supply from SSEN – John Ennis said if urban bus fleet was totally electrified (25 new vehicles expected very soon to start this) would alone require 8% of Reading's electricity (supply or consumption? – was not clear).

John Ennis commented that the Council wants to reduce traffic congestion of all forms irrespective of power source.

Transport Strategy update to 2040 had been approved unanimously at SEPT.

Active Travel: Cycle lanes and various other improvements were in progress. New school at Rivermead means Cow Lane underpass crossings are to be upgraded to provide cycling and pedestrian priority.

John Booth questioned expected 2040 indicator of 54 kT CO2 from transport, and lack of an indicated outcome for costs of congestion in Reading. It appeared the CO2 indicator was essentially a target to do better than government requirement and not based on detailed analysis or simulation. Cllr. Ennis agreed these questions were important and invited us to get back to him.

AOB: John Sharpe asked if something could be done about deliberately loud engines being used on cars and motorbikes. Council agreed it was an issue.

RBC Strategic Environment Planning and Transport Committee:

Latest committee meeting was on June 27th. Lots of interesting topics. Largely positive policies. Agenda and link to webcast at https://democracy.reading.gov.uk/ieListDocuments.aspx?Cld=139&Mld=5400

Item 7: Local Development Scheme – draft of Local Plan delayed 4 months until November 2024.

Item 8: *Low Carbon Capital Investment Programme*. Borough up-grading its buildings, often with heat pumps. 90% of £7.1 million 5-year programme spent or committed to live projects. £2.17m corporate solar programme has yet to be mobilised.

Item 9: Reading Transport Strategy 2040. Consultation report said:

"There were a significant number of positive responses with regards to **congestion charging** as a method to fund the schemes and initiatives in the strategy. A reasonable number of responses included suggestions that any implemented congestion charging scheme should target through-traffic as opposed to Reading residents."

"Opinions on a **Third Thames Crossing** were predominantly positive, and respondents considered it to be an important infrastructure project in reducing congestion in Reading and reducing cross-river journey times. Some comments also note that any new cross-river project should be provided exclusively for more sustainable travel modes such as cycling and public transport and should not encourage an increase in private vehicle use and induced traffic in the surrounding areas. A minority of comments were concerned about the environmental impacts of a new crossing."

Item 9: Reading Transport Strategy 2040. Final approved version:

No results for simulation of alternative scenarios

Performance Indicators: delete next page break

- No estimate for costs of congestion
- Transport carbon emissions still "54 kT CO2 per year (less if possible)" in 2040.
- No indicator for transport emissions affecting air quality.

Item 11: **Bus Service Improvement Plan.** Updated version approved for submission to government. Reports on past and proposes new measures. Green party objection to London Road bus lane discussed.
