<u>General Meetings:</u> Reading FoE usually (but not in November 2024) meet on the **second Wednesday of each month** either in person or on Zoom. Often in Room 1 upstairs at RISC, 35-39 London Street, at 7:30 p.m. Access to RISC from London Street is via a passage to the right of the shop-front. Most meetings will be 'hybrid' - please request a Zoom link if you have not received one. Most meetings discuss plans and general topics - some have a particular focus or guest speakers.

Thursday (not Wednesday) **14th November** Our November monthly meeting will be held in Room 3 at RISC and on Zoom at 7:30. We will start with a presentation on **Heat Pumps** by guest speaker Mike Smith covering the basics of heat pump systems and their real world performance plus a few observations on issues in moving away from reliance on gas as a heating fuel (more detail below). Then we will discuss future campaign activities, meetings, etc.

Wednesday 11th December 7:30 pm. Fox and Hounds in Caversham - in person only. We should discuss plans for 2025. (Provisional – check for changes nearer the time. Dress warmly in case noisy guests move us outdoors.)

Our January newsletter featured a campaign for cycling from 1975. March: 'Save the Whale' from 1979. May: loft insulation from c. 1979. July: a celebration of national FoE 10th birthday from 1981. September: 'The Big Ask' climate change campaign from 2006.

In **December 2022** we launched our **Campaign for Warm Homes** with a photo-call for the National Day of Action. It was good to see so many people outside the Town Hall. Thanks to friends from Greenpeace, XR, Green Party and Global Justice, and to Graham for assembling placards and Anne for the photograph! We eventually handed in our petition to local parliamentary candidates before the 2024 election.

Reading FoE monthly meeting - Heat Pumps in the Real World

Our November monthly meeting will be held on Thursday (not usual Wednesday) **14th November** in room 3 at RISC at 7:30. The in-person meeting will be also be live-streamed on Zoom - please e-mail info@readingfoe.org.uk to be sent Zoom link if you have not received one. We will start with a presentation on Heat Pumps by Mike Smith for the first hour or so after which we will discuss future campaign activities, meetings, etc. All welcome.

The presentation will cover the basics of heat pump systems and their real world performance plus a few observations on issues in moving away from reliance on gas as a heating fuel.

Mike Smith was formerly the Engineering Director of BSRIA, a membership based, non-profit distributing, specialist test house serving the building engineering services sector of the Construction Sector. During the 20 years as Director, he specialised in many areas but particularly testing and research related to heat pumps, including involvement in the European Heat Pump Association.

Delivering FoE's Climate Change Act Report to MPs and further actions on climate.

To mark the 16th anniversary of the Climate Change Act on **26 November** Friends of the Earth is publishing a report to showcase what the Act has achieved so far, and how its future legacy is under threat. They suggest we hand deliver a hard copy to our MPs – ideally in person or to their office. If we sign up to this they will send us a printed copy of the report along with a link to a template foreword that we can adapt. https://forms.friendsoftheearth.uk/climate-change-act-report-delivery. This would be a good way to follow up our October meeting with 'our' three MPs – will discuss at our meeting on 14th.

FoE also propose we **start a local petition** in support of a 'Big Climate Plan'. Current Issues:

COP29 – November 11th to 22nd https://cop29.az/en/home

This year's 'conference of the parties' to the U.N. Framework Convention on Climate Change (UNFCCC), runs from November 11 to 22, in Baku, Azerbaijan. The theme of COP29, according to the Azerbaijan presidency, is "in solidarity for a green world". It has been termed the 'Finance COP' because agreeing on a new climate finance goal is top of the agenda, alongside a call to countries to update their national climate commitments ahead of COP30.

Much has been written about the urgency for action – recent research claims that climate change made the ten deadliest extreme weather events of the last 20 years more intense and more likely https://www.bbc.co.uk/news/articles/cdxvnk10xz20.

Some countries feel more threatened than others. Anneliese Dodds MP told a recent Westminster Hall COP29 debate "I was in New York for the UN General Assembly with some representatives of small island developing states, which are particularly hard hit. They said that **their slogan used to be, "1.5 to stay alive," but it is becoming, "1.5 and we might survive"**. This really is urgent, and the new UK Government are determined to do all we can to exercise leadership, working in partnership with others."

Wokingham Local Plan Revision:

Consultation closes 13th November https://www.wokingham.gov.uk/planning-policy/emerging-local-plan-update
Still proposes Hall Farm development south of Earley, now renamed "Loddon Valley Garden Village" for 3,930 dwellings, of which at least 2,700 dwellings will be delivered by 31st March 2040. Current proposal does not include a

new M4 junction but a bridge over it to allow a new road to reach the Earley Outer Peripheral Road which will probably need to be widened to take traffic growth and allow for public transport and active travel..

West Berkshire Local Plan and Pincents Hill:

At the examination in public the Inspector has recommended that development of Pincents Hill should be included in the version that goes to the next phase – despite the arguments put by Olivia Bailey MP and local people.

Reading Borough Council Strategic Planning and Transport Committee:

Recent Activities with Reading FoE:

'Climate Coalition' 'Day of Action'

We met with three local MPs on 11th and 12th October and were joined by other constituents who supported Greenpeace, XR, Global Justice Now and Greater Reading Environmental Network. FoE's main theme was the call for a bold, fair and ambitious action plan. In Earley we also talked about the Climate and Nature Bill (a 'Private Members' Bill currently before parliament calling for mandatory targets https://www.zerohour.uk/secondreading/), the Fossil Fuel Non-Proliferation Treaty initiative https://fossilfueltreaty.org/about-treaty and Draughtbusters and similar local initiatives.
